- I have reviewed the accompanying Statement of unaudited standalone Financial Results
  of KPT Industries Limited ("the Company") for the quarter ended 30<sup>th</sup> June 2022 ("the
  "Statement"), being submitted by the Company pursuant to the requirement of
  Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations,
  2015, as amended.
- 2. This statement which is the responsibility of the Company's Management and approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 " Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013 ("the Act"), read with the Companies (Indian Accounting Standards) Rules, 2015, as amended, and other accounting principles generally accepted in India.
